

Reminder: New PA Medical Malpractice Venue Rule Went Into Effect January 1

With the New Year came the end of Pennsylvania's "venue carve-out rule" for medical malpractice cases.

Effective January 1, 2023, Pennsylvania plaintiffs can once again bring their medical malpractice claims in any county in which care occurred, where a defendant could be served, or where any transaction or occurrence giving rise to the claims took place.

The venue carve-out rule, provided by Pa. Rule of Civil Procedure 1006(a.1), stated that a medical malpractice case could only be brought "against a healthcare provider in the county in which the cause of action arose."

The rule was part of 2002's Medical Care Availability and Reduction of Error Act, known as the MCARE Act. The MCARE Act was passed during the wave of late 1990s/early 2000s tort reform brought into the state through well-funded insurance and business interest groups.

The business lobby and defense bar claimed the venue carve-out rule would eliminate frivolous claims and prevent forum shopping. But what it actually did was prevent victims of medical malpractice from being able to file claims in a venue of their choosing based on the general venue rules set forth in Rule 1006(a) that governed non-medical malpractice cases.

Last August, the Pennsylvania Supreme Court approved amendments to Rule 1006 that did away with the rule. Those amendments became effective on January 1, 2023.

With the rule change, we expect defendants to aggressively challenge venue in medical malpractice cases when the venue is not the county where the treatment was given.

- Even after the case is settled it can take additional time for all of the bills and lien to be paid.

Understanding that this is a long process and deciding the stick with the process will make a huge difference in the value of your claim and the amount of money you receive as compensation for your injuries.



LAURA CARPEY'S RECIPE OF THE MONTH

Lamb Chops with Lemon, Thyme & Mustard Butter

These French-inspired lamb chops cook under the broiler, so they're quick and flavorful.

INGREDIENTS

- 4 Tbs. unsalted butter, softened
- 1 tsp. whole-grain Dijon mustard
- 1 tsp. fresh thyme leaves, lightly chopped
- 3/4 tsp. finely grated lemon zest
- 1/8 tsp. kosher salt; more as needed

- 1/8 tsp. freshly ground black pepper; more as needed
- 8 lamb loin chops (1-1/2- to 2-inch-thick chops; about 3 lb.), trimmed

INSTRUCTIONS

combined. Refrigerate

1. In a small bowl, mash together the butter, mustard, thyme, zest, salt, and pepper until well

until ready to use. 2. Position an oven rack 5 to 6 inches from the broiler element and heat the broiler to high. Line the bottom of a broiler pan with foil and replace the perforated top part of the pan. Arrange the chops on the pan. Season both sides of the lamb generously with salt and pepper. Broil until the first side is wellbrowned,

about 8 minutes. Turn the chops over with tongs and continue to broil until they're well browned and the center is cooked to your liking, 3 to 5 minutes longer for medium rare (cut into a chop near the bone to check).

3. Transfer the lamb to serving plates and top each chop with a dab of the flavored butter. Serve hot.
