



LAURA CARPEY'S RECIPE OF THE MONTH

Apple Coffee Cake

INGREDIENTS

Streusel Topping

- 2/3 cup Bisquick mix
- 2/3 cup packed brown sugar
- 1 teaspoon ground cinnamon
- 1/2 teaspoon ground nutmeg
- 6 Tablespoons cold butter or margarine

Coffee Cake

- 2 cups Bisquick mix
- 3/4 cup milk, or a little more if batter seems thick
- 3 tablespoons granulated sugar
- l egg
- 2 medium cooking apples, quartered, peeled and sliced
- 1/4 cup chopped nuts

Glaze

- 1/2 cup powdered sugar
- 2 to 3 teaspoons milk

INSTRUCTIONS

1. Heat oven to 400°F. Spray an 8 or 9-inch square pan with cooking spray. In small bowl,


mix 2/3 cup Bisquick mix, brown sugar, cinnamon and nutmeg. Cut in butter, using pastry blender (or pulling 2 knives through ingredients in opposite directions), until crumbly; set aside.

2. In medium bowl, stir together 2 cups Bisquick mix, 2/3 cup milk, the granulated sugar and egg; beat vigorously 30 seconds with spoon. Spread half of batter in pan. Arrange apple slices on batter; sprinkle with half of streusel topping.

Spread with remaining batter; sprinkle with remaining topping. Sprinkle with nuts.

3. Bake about 25 minutes or until toothpick inserted in center comes out clean. Cool in pan on cooling rack 20 minutes. In small bowl, stir glaze ingredients until smooth enough to drizzle. Drizzle glaze over warm coffee cake.
